

Program Outcomes

Emergency and Family Services

370 clients used our food pantry at least once per month

Number of clients who received 20 TARC tickets every other month: **229**

Glade House Emergency Shelter

The three emergency beds had a utilization rate of 99%

85% of clients exited to more stable housing

75% of clients left with increased income

Glade House Short-term Housing

100% of clients who graduated the program moved to long-term housing

Of the clients who remained at Glade House for at least 9 months, 88% managed their addiction and stayed housed

Long-Term Housing

59 households, including **91**, individuals received subsidized rent and case management
